compliance with College and unit-level bylaws; Serve as member of the Dean's Senior Staff, which works as a team on College planning and management; Work with the Dean regarding active Office of Institutional Equity (OIE) investigations involving violations of the MSU Anti-Discrimination Policy, MSU Relationship Violence and Sexual Misconduct Policy, or the College of Social Science Community Code of Conduct, recommending and implementing interim actions as needed; Work with unit-level leaders in the College to ensure that policies and practices related to offers of employment, annual performance evaluations, and reappointment, tenure, and promotion decisions for faculty and academic staff are fair and equitable; Collaborate with the Associate Dean for Undergraduate Education to develop and implement strategies to address opportunity gaps among the undergraduate student population and expanding access to MSU through precollege pathway programs supporting historically underrepresented, low income, first gen, and/or Pell grant eligible students; Collaborate with the Associate Dean for Graduate Studies to develop and implement strategies to support the recruitment, advancement, and retention of graduate students from diverse backgrounds throughout the College's academic units; Collaborate with the College Human Resources Director to develop and implement strategies to support the recruitment, advancement, and retention of staff from diverse backgrounds throughout the College and the College's academic units.

Associate Dean for Diversity, Equity, and Inclusion, Executive Leadership, Dean's Office, College of Social Science, Michigan State University, Fall 2020-23.

Scope of Responsibilities

The Associate Dean for Diversity, Equity, and Inclusion has overall responsibility for College activities designed to enhance and maintain a diverse, equitable and inclusive culture for faculty, students, and staff. She leads Chairs and Directors and others in the implementation of DEI section of the College's Strategic Plan; represents the College in meetings on issues involving diversity, equity, and inclusion; functions as the College liaison to the Office for Inclusion and Intercultural Initiatives (OI3) and the Office of Institutional Equity (OIE); provides required briefings for search committees and manage approval processes of candidates, short-lists, and offers with OI3; oversees processes to elect representatives to College and University Committees, in compliance with College and unit bylaws; works with the Dean regarding active OIE investigations, recommending interim actions as needed; collaborates with the Dean and the Associate Dean for Faculty Affairs on disciplinary actions; leads the process of approval and implementation of the College's policies on civility, professionalism and community norms; chairs the Dean's Advisory Board on Diversity and Inclusion (DABDI), which provides guidance, makes recommendations to the Dean about diversity-related concerns, and sponsors initiatives that support efforts to understand and celebrate the differences among us; pursues development activities with individuals, corporations and foundations, as well as lead an external component of the Dean's Advisory Board on Diversity and Inclusion; serves as a member of the Dean's Senior Staff, which works as a team

on College planning and management; works with the other Associate Deans and College leaders to enhance diversity, equity and inclusion in each of their functional areas; serves as the College Faculty Excellence Advocate; performs other duties as assigned by the Dean of Social Science.

Outcomes and Accomplishments

1. Leading (advancing, implementing, and executing) the College of Social Science (SSC) college-wide “Diversity and Inclusion” initiative, which has a focus on developing future faculty, and increasing the proportion of tenure-system underrepresented (URM) senior faculty via recruitment, support, and retention.

Racial Demographics (excluding Asians and International—2019-20 figures): MSU has a total tenure system faculty of 1978, of which 13 are Native-American; 89 are Black or African American; 3 are Native Hawaiian; 100 are Hispanic; and 9 are multiracial. The total number of minority tenure system faculty is 214 or 10.8%. In comparison, SSC has a total tenure system faculty of 315, of which 3 are Native-American; 18 are Black or African American; 0 are Native Hawaiian; 24 are Hispanic; and 3 are multiracial. The total number of minority tenure system faculty in SSC is 48 or 15.2%.

- a. Faculty Hiring: Created and implemented the SSC Dean’s Distinguished Senior Scholar Program—an initiative aimed at recruiting and retaining senior high performing URM scholars, who, through their research, teaching, and service, contribute to diversity, and equal opportunity. We made one senior high-profile African American scholar hire in Human Development and Family Studies for academic year 2020. *This senior hire represents a growth in tenure-stream African American faculty at MSU from 4.5% (89) to 4.6% (90); and a growth in tenure-stream African American faculty in the SSC from 5.7% (18) to 6% (19). It also represents a growth in the number/percentage of African American full professors in SSC from 2.8% (9) to 3% (10).*

In process of hiring two additional senior scholars for academic year 2022-23.

- b. Future Faculty Hiring: Created and implemented an SSC Dean’s Research Associate (Postdoc) Program—an initiative aimed at promoting an inclusive scholarly environment where outstanding URM scholars in the social sciences who, through their research, teaching, and service, contribute to diversity, and equal opportunity. Each Research Associate will be transitioned into the tenure stream at Michigan State University at the successful conclusion of two years. The first cohort of three Research Associates were hired in August 2019 into the departments of Anthropology (Native American male), History (African American female), and Sociology (African American female). Each Research Associate has been transitioned

into the tenure stream for August 2021. *These hires represent a growth in tenure-stream Native American faculty at MSU from .65% (13) to .71% (14); and African American faculty from 4.6% (90) to 4.7% (92). Likewise, they represent a growth in tenure-stream Native American faculty in the College of Social Science from .95% (3) to 1.2% (4); African American faculty from 6% (19) to 6.7% (21).*

The second cohort of four Research Associates were hired in August 2020 into the departments of Human Development and Family Studies (African American female), School of Social Work (African American female), Political Science (African American female), and Sociology (Arab American female). Each will be transitioned into the tenure stream in August 2022. *Once transitioned into the tenure stream in 2022, these hires will represent a growth in tenure-stream African American faculty at MSU from 4.7% (92) to 4.8% (95). Official figures do not exist for Arab American faculty. Likewise, these hires will represent a growth in tenure-stream African American faculty in the College of Social Science from 6.7% (21) to 7.6% (24). Official figures do not exist for Arab American faculty.*

The third cohort of four Research Associates were hired in August 2022 into the departments of Anthropology (African American male), School of Social Work (African American female), Political Science (Hispanic male), and Economics (Hispanic male). Each will be transitioned into the tenure stream in August 2024.

- c. Faculty Retention: Regularly meet with individual SSC tenure stream faculty as a check in; created and administer exit interviews with SSC faculty that left MSU in the past six years to find out why they chose to leave.
 - d. Future Faculty Development: Created and lead the SSC Dean's Research Associate Development Institute (DRADI). Underrepresented faculty face many barriers within institutions of higher education. DRADI promotes and enhances the careers of the future faculty hired into the SSC Dean's Research Associate Program by addressing institutional barriers that have constrained the advancement of underrepresented future faculty in the social sciences. It is designed to provide ongoing professional and personal support to ensure long term professional success. It also targets institutional culture and practices that may hinder the retaining of these diverse individuals. The two-year training institute is structured, comprehensive, and holistic, and combines research training, with pedagogical training, and academic professional development opportunities, to aid in preparing the research associates for the responsibilities of an academic faculty position at MSU.
2. Academic Search Best Practices: Overhauled the faculty search process by introducing search training workshops in best practices and implicit bias, thereby replacing passive search techniques with active recruiting strategies for

qualified URM candidates. Innovations introduced include: developing and administering mandatory faculty and administrative leadership search and hiring training workshop in best practices and implicit bias to all members of department/school search committees in SSC; working with search committees on, and approving, job advertisements before posting; having each job posting be foregrounded with language that demonstrates MSU's commitment to inclusive excellence, and making mandatory, diversity statements, for all SSC searches; working with search committees on best practices for being proactive about attracting a diverse candidate pool; performing diversity checks on candidate pools with Office of Institutional and Intercultural Initiatives (OI3).

3. Inclusive Climate: Created and chair an internal Dean's Advisory Board on Diversity and Inclusion (DABDI), whose primary function is to provide guidance, and make recommendations to the Dean, in addressing diversity-related concerns, and sponsoring initiatives that support efforts to understand and celebrate the differences among us. Presently working to create an external alumni giving DABDI board.

DABDI has evolved into the new Dean's Advisory Committee on Diversity and Inclusion (DACDI). In process of codifying DACDI as a standing committee in SSC bylaws.

4. Annual Review and Retention, Promotion, and Tenure (RPT) Process: Reach out and meet with new faculty at least once a year to introduce them that MSU's *Annual Review Tool Kit*, determine if mentors have been provided them, and see how these new faculty are acclimating within their department, the college, the community; answer whatever unanswered questions or concerns they might have, and make sure that they are clear on the criteria and the process for evaluation; review and provided advice and guidance of RPT documents as requested; serve as ex officio member of SSC RPT committee.
5. Mentoring: Performed review of SSC mentoring programs; created a pilot mentoring program at the College level, which will serve the needs of all faculty.
6. DEI Leadership Professional Development: created a Dean's Diversity, Equity, and Inclusive Leadership Program which simultaneously provides DEI leadership training and professional development with opportunities to publish in DEI specific journals or outlets.
7. DEI Small Grants Program: created and lead a Dean's Diversity, Equity, and Inclusion small grants program to fund faculty, staff, and graduate students who research or innovations advance DEI in SSC.

Scope of Responsibilities

Successful management of crisis around HRLR Director search led to appointment as Responsible administrator. Appointed to maintain the status quo in the school until a new director was selected. As Responsible Administrator, supported and helped 3 candidates put together tenure and promotion files and identify external evaluators; prepared and got sabbatical requests approved for 1 faculty member; was signatory on all academic human resource issues in the school, including appointments, raises, pay slips, time sheets, approval of travel etc.; and supervised a staff of three.

The College of William and Mary is a public research university located in Williamsburg, Virginia. Founded in 1693, it is the second oldest institution of higher education in the United States, after Harvard. One of eight “Public-Ivy” institutions, William and Mary offers a world class education

The Chinua Achebe Colloquium on Africa, has variously been convened at Bard College, Annandale-on-Hudson, New York, Brown University, Providence, Rhode Island, and now, Princeton University, Princeton, New Jersey, and brings together an international group of scholars, officials from African governments, the United Nations, the United States, the European Union, and other organizations for intense deliberation and exchange of ideas on the importance of strengthening democracy and peace on the African continent.

The Chinua Achebe Leadership Forum is a high-profile international platform which brings together international leaders and thinkers to discuss Africa's challenges, in keeping with the life and work of Professor Chinua Achebe. The Chinua Achebe Leadership Forum has hosted two Ghanaian Presidents—John Dramani Mahama (2013) and Nana Akufo-Addo (2019); South African President Kgalema Motlanthe (2018).
